Classifiers' Report:

- Classifiers have been present at WNY and Beast of the East both two day tourneys – harder to observe (ex. 25 players assessed in WNY)
- Classifiers have been present at WNY and Beast of the East both two day tourneys. With the two day tournaments, physical assessments are take Friday evening most of Saturday, so, court observation is beginning late Saturday and many decisions are not being made until after crossovers Sunday. With this

- happening, changes to class and this line-ups do not take affect in this tournament so results may be skewed for post season rankings.
- In addition, Unable to do many rechecks, even starting on Friday and working until 11pm each night. Teams and classifiers may consider earlier arrival on Friday of two-day tournaments to allow bench tests to begin sooner
- Metal and Muscle looking at around 40 athletes that need to be assessed
- Need teams to prioritize submission of rosters to tourneys sooner allowing classifiers to get schedule done in a more timely manner
