# **Referees' Report:**

# **Lakeshore Representative Report - Beth Curry:**

- Lakeshore holds no jurisdiction over USQRA in this area, but USAWR is very involved in SafeSport policy requirements for the national team. If they held jurisdiction over the club system as an NGB would, those same requirements would be in place for USQRA.

  - All NGB's and HPMO's, including Lakeshore/USAWR have undergone a third party audit relative to SafeSport. The only recommendation received was minor and has been rectified. USQRA can discuss SafeSport operations with Beth Curry in the future if interested.
